- 1. Whereas the Election of the Office Bearers and Members of Executive Council of IOA would be held as per Memorandum and rules and regulations of Indian Olympic Association amended upto 08.12.2013 and Election Bye-laws, which were sent with notice dated 4 January, 2014.
- 2. The nomination of a candidate for election as Office Bearer or a Member of Executive Council shall be proposed by one of the representatives of Member Sports Federation/ State/Union Territories/SSCB whose name is included in the Electoral College list in Form 1 and also subscribed by 1 (one) such representatives as seconder.
- 3. No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder; and, if he so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
- **4.** No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been delivered to Returning Officer.
